ORDINANCE ADOPTING A BIKE LOAN PROGRAM FOR OFFICIALS AND  
EMPLOYEES OF THE CITY GOVERNMENT OF MARIKINA

WHEREAS, the City Government of Marikina has completed the construction of a 24-kilometer locally funded bikeways and 4.3-kilometer of World Bank financed bikeways and has conducted various campaigns to promote the use of bicycle as an alternative mode of transport in the City;

WHEREAS, a Bike Loan Program has been adopted in 2004 with the funding coming from the World Bank-GEF Trust Fund;

WHEREAS, the use of bicycle as a means of transportation is being encouraged in the City of Marikina;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled that:

SECTION 1. The City Government of Marikina hereby adopts a bike loan program for the benefit of its officials and employees.

SECTION 2. *Coverage.* All city officials and employees, whether regular, casual, contractual, project-based and service volunteers are qualified to avail of the bike loan program, provided that:

- a) The net home pay of every employee shall not be less than One Thousand Five Hundred Pesos (Php1,500.00); and
- b) In case of casual, contractual, project-based workers, a co-maker (regular employee) shall be required.

SECTION 3. *Funding.* The City Government of Marikina shall allocate funds to carry out this program which shall be taken from any available funds.

SECTION 4. *Implementing Authority.* The City Personnel Office, the General Services Office and the City Treasurer's Office are hereby tasked to formulate the guidelines for the implementation of this Ordinance.

SECTION 5. This ordinance shall take effect upon approval.


